2015 Berkshire Pontoon Boat Rental Information and Agreement

DAILY RATE: 24’ – 115 HP \$350 per day plus Fuel and MI sales tax
 22’ – 60 HP \$300 per day plus Fuel and MI sales tax
 18’ – 60 HP \$250 per day plus Fuel and MI sales tax

Half day rentals cannot be reserved and are based on same-day availability.

24’ – 115 HP \$235 for (4) hours plus Fuel and MI sales tax
 18’ & 22’ – 60 HP \$200 for (4) hours plus Fuel and MI sales tax

WEEKLY RATE: 24’ – 115 HP \$2100 for (7) days plus Fuel and MI sales tax
 22’ – 60 HP \$1800 for (7) days plus Fuel and MI sales tax
 18’ – 60 HP \$1500 for (7) days plus Fuel and MI sales tax

PAYMENT: One day’s rental fee will be paid at the time the reservation is made. For multiple day rentals, the balance due must be paid before the boat leaves the marina. We accept cash, checks and credit cards. For all customers paying by credit card, a 3% surcharge will be added to the amount due.

HOURS: Pontoons are to be picked up and dropped off at Mullett Lake Marina ONLY. Out after 9:00am – Return by 6:00pm. LATE FEE will be charged to your credit card at a rate of \$25 per QUARTER HOUR. PLEASE DON’T BE LATE.

RESPONSIBILITY: The signer of the rental agreement must be 21 years of age with a valid Driver’s License. Signer assumes full responsibility and liability for the boat, all passengers, all equipment and the safe operation of the boat.

SECURITY DEPOSIT: A security deposit equal to one day’s rental fee must be secured by a credit card and is subject to a temporary hold for the duration of the rental period. The hold will be placed on the credit card provided as a security against any possible damages or unpaid charges.

PET POLICY: We do not allow any pets aboard our vessels, with the exception of Certified Service Animals. If we find evidence that a pet has been aboard, a cleaning fee of \$75 will be charged, in addition to any damages.

CANCELLATION: Full refund of the paid rental fee only if cancellation notice is given at least (1) week prior to reservation. \$100 shall not be refunded if cancellation is less than 1 Week before rental date (unless boat rents).

RAIN CHECKS: We cannot be responsible for the weather, but will not put boaters out in unsafe conditions. We will do our best to first reschedule, and then refund the rental fee.

FUEL USAGE: The customer is responsible for fuel usage and will be determined when the boat returns.
